PUBLIC NOTICE: INSTITUTIONAL ROUND ADMISSIONS 2026-27

Admission to Vacant Seats After CAP Rounds (Direct Second Year B. Pharmacy)

Applications are invited from eligible and aspiring candidates for admission against the seats remaining vacant after the completion of all Centralised Admission Process (CAP) rounds conducted by the **State Common Entrance Test Cell, Maharashtra** for the Academic Year 2026-27.

This institutional admission process is being conducted in strict compliance with the directives, schedules; and regulations issued by the CET Cell, Maharashtra.

1. Core Principles of Allotment (As per Rule 13)

- **Merit-Based Admissions Only:** As per **Rule 13** of the official Information Brochure, all vacant seats will be filled strictly on the basis of the **Inter-se Merit** of the eligible candidates who apply.
- **Zero Arbitrary Allocation:** The institute will not allot seats arbitrarily. The merit list will be drafted considering only valid applications that match the official list of registered candidates provided by the CET Cell.
- **Reservation Category Protocol:** Any seat remaining vacant after the CAP rounds will first be made available to candidates belonging to the same category for which it was originally earmarked. If no candidate from that specific category is available, it will be filled based on general inter-se merit as per state regulations.

2. Application Procedure

Eligible candidates can apply for the Institutional Vacancy Round using either of the following two official pathways:

1. **Direct Campus Application:** Visit the college admission cell in person to collect, fill out, and submit the physical application form along with the necessary document copies.
2. **Online Portal Login:** Submit the **Institutional-level Option Form** directly by logging into your candidate profile on the official CAP portal.

Note: Only candidates who have already registered on the CET portal and successfully completed their document verification (E-Scrutiny or Physical Scrutiny) are eligible to participate.

3. Schedule & Transparency

- **Seat Matrix Visibility:** The detailed branch-wise and category-wise vacant seat matrix will be prominently displayed on the institute's notice board and official website immediately upon the conclusion of the final CAP round reporting phase.
- **Merit List Publication:** Upon receiving and processing applications, the college will generate and transparently display the **Institutional-Level Merit List** on the college website and physical notice board before conducting the counseling rounds.
- **Instant System Update:** Immediately after a seat is allocated and accepted, the college will instantly upload and confirm the admission details onto the official online CAP portal.

4. Mandatory Statutory Warning

- **Anti-Fraud Advisory:** The CET Cell explicitly cautions parents and students against private consultants, agents, or middle-men claiming to guarantee seats through unauthorized channels. **No third-party intermediaries are authorized to handle admissions.**
- **Information Verification:** Candidates must rely strictly on information published on the official college website or the Official Maha CET Portal. The college bears no responsibility for misleading claims made via private counseling services or unofficial links.

- ❖ Reporting of interested candidate for admission: 14/09/2026 from 10:00 AM to 12:00 PM.
- ❖ Display of allotment list: 14/09/2026 at 12:30 PM.
- ❖ Confirmation of admission by submission of documents and paying fees: 14/09/2026 at 2:00 PM.

Allotment process: Stage I

- 1) Allotment will be considered for OBC candidate for 1 (One) vacant seat on Inter-Se-Merit. OBC candidate with highest D. Pharm will be considered for allotment, if

topmost candidate is not willing to confirm his/her admission, seat will be allotted to OBC candidate on Inter-Se-Merit.

- 2) If no OBC candidate is available, candidate belonging to Maharashtra State from general institute will be offered seat on Inter-Se-Merit list.
- 3) If no Maharashtra State candidate is available, seat will be offered to non-Maharashtra candidate on Inter-Se-Merit.

Allotment process: Stage II

If there is availability of any other seats on account of admission cancellation before the cut-off date, i.e. 13/09/2026, then the seat will be allotted as per the following procedure:

- ❖ Display of available seats for admission: 14/09/2026 at 10:00 AM
- ❖ Allotment of seats will be preferred to candidates from the appropriate category on inter-se-merit.
- ❖ If a candidate of the appropriate category is not available, then M.S. candidate will be preferred on inter-se-merit.
- ❖ If M.S. candidate is not available, then OMS candidate on inter-se-merit will be preferred.

In both the stages for allotment, it will be binding on the allotted candidates to confirm their admission by 14/09/2026 itself.

6. Documents Required for Verification

Candidates must bring **three sets of self-attested photocopies** along with all **original documents** at the time of reporting for spot counselling:

- **CAP Registration Acknowledgment Receipt** (FC/SC verified copy)
- **HSC (Class 12th) Mark Sheet & Passing Certificate**
- **SSC (Class 10th) Mark Sheet & Passing Certificate**
- **School / College Leaving Certificate (TC)**
- **Indian Nationality Certificate / Domicile Certificate**
- **Caste Certificate, Caste Validity Certificate, and Non-Creamy Layer Certificate** (Valid up to March 31, 2027) *(Only if applying against category-converted vacant seats)*
- **Migration Certificate** *(For OMS / Other-than-Maharashtra State Board candidates)*
- **EWS / TFWS Income Certificate** issued by the competent authority *(If applicable)*

7. Fees:

The Fee Regulatory Authority (FRA) has fixed the fees of B. Pharmacy First year for A.Y. 2025-26. Fees for direct second year candidates for A.Y. 2026-27 will be same as fee fixed for B. Pharmacy first year for A.Y. 2025-26. The fee structure approved by Fee Regulatory Authority (FRA) is as shown below:

Tuition fees: Rs. 85904

Development fees: Rs. 11596

Total fees: Rs. 97500
